PARENT & STUDENT AGREEMENT

Parents and Students please read below.

IN GENERAL : Your child has enrolled in this course solely for the purpose of preparing for the **S.A.T.** Test Prep Institute (henceforth TPI) may change course schedules and locations, and, on rare occasions, cancel a course; TPI will notify you immediately if this occurs. Class size is limited to 15 students and enrollment is taken on a first-come, first-served basis. TPI may dismiss any student whose course fee has not been paid on time, or who, in instructor's opinion, is disruptive.

Our experience clearly shows that those students who attend all scheduled meetings achieve the greatest score improvements. But if you must miss a meeting, we can do the following:

1. If you miss a **TEST SESSION**, we will give you the exam to take at home or you can arrange to take it during a future testing session.
2. **WORKSHOP** sessions are difficult to make up due to their interactive nature; however, you may make arrangements to attend a make-up session which is offered near the end of each course.

COURSE FEES: The **\$1295** fee for the **S.A.T. COMPREHENSIVE REVIEW** is all-inclusive: all classes, workshops, tests, and materials are provided by TPI. A deposit of **\$295** will reserve a space in the SAT course. This deposit is refundable up to three (3) business days before the beginning of the class. Payment in full is expected on (or before) the first day of class. Students who have not paid in full by the first diagnostic test will **NOT** be admitted to class.

REFUNDS: If the student changes his/her mind prior to three (3) business days before the beginning of the course, payment will be fully refunded. If the student desires to withdraw after the course begins, TPI will refund the pro-rated balance based on the course schedule. All refunds require that the student notifies TPI in **WRITING**, and refund amounts will be calculated from the day written notice is received. **After the first two class meetings, tuition is neither refundable nor applicable towards private tutoring.** All TPI materials must be returned upon withdrawal from the course. Refunds will not be granted until all course materials are returned.

GUARANTEE: If the student completes his/her homework assignments on time and attends all classes, tests, and workshop sessions, his/her SAT scores should improve at least **150 points** (M + V combined). If not, TPI will allow him/her to attend the next available **SAT COMPREHENSIVE REVIEW** class at the reduced price of \$695. Thereafter, any student who desires to repeat the same course will be assessed a "continuation fee" of \$375 to sit the **SAT COMPREHENSIVE REVIEW** course one final time. All SAT scores improvements will be measured from the first diagnostic exam delivered at T.P.I.
